APPLICATION FOR TRADE STAND SPACE THE GREEN, DENBIGH, DENBIGHSHIRE GENERAL INFORMATION AND REGULATIONS

The Denbighshire and Flintshire Show is now acknowledged as the greatest one-day Show in North Wales. Average attendance 18,000.

All services are available and the Society will assist exhibitors in every way possible, including the reserving of Electricity.

THE SHOWGROUND is level and adjoins the main Mold to Denbigh (A541) and Denbigh to St. Asaph (A525) roads and is easily reached from the fertile Vale of Clwyd farming district.

SCHEDULE OF CLASSES includes Heavy Horses, Hunters, Riding Ponies, Arabian Horses, Shetland Ponies, Welsh Cobs, Welsh Mountain Ponies, Dairy and Beef Cattle, Sheep, Goats, Poultry, Pigeons, Rabbits, Lamb Carcase Competition, Floral Art, Young Farmers, Merched y Wawr and Women s Institute Competitions, Horse Jumping, Honey, Horticulture, Vintage and Classic Cars, Vintage Machinery, Food Hall.

Open Space for Exhibitors erecting their own Marquees or Stands with frontage to the avenues. For charges see Trade Exhibit Entry Form. Exhibitors are asked to state the number of units required. Size of Unit 4m. frontage by 8m. depth.

Allowance must be made for guy ropes and caravan towbars when estimating space required.
These must be included in the Trade Stand Area.

THE ATTENTION OF INTENDING EXHIBITORS IS DRAWN TO RULE 11. ON NO ACCOUNT WILL APPLICATIONS FROM EXHIBITORS CONSIDERED LIKELY TO CAUSE ANNOYANCE TO OTHER STAND HOLDERS BE CONSIDERED, E.G.: BINGO STALLS, ETC.

Exhibitors will receive a limited number of free tickets to the Show based on the value of the Space taken (see regulation 3 overleaf).

Exhibitors may purchase Advance Booking Tickets for the use of their Staff at reduced rates. Make sure you order a sufficient quantity. The Admission Charge on Show Day will be £10.00 (incl. V.A.T.) for Adults.

MEMBERS of the Society will also receive badges and members Car Park Passes, as well as enclosure access.

SPECIAL PRIZES. The Society offers a Cash Prize of £40.00 for the Best Trade Stand in each of the following Sections:

- a) Best Agricultural with Machinery.
- b) Best Agricultural Requisites.
- c) Best Non Agricultural - up to 5 units.
- d) Best Non Agricultural - 6 units and over.

REGULATIONS

1. Intending Exhibitors must complete the Entry Form and forward It to the Secretary TOGETHER WITH PAYMENT for all necessary requirements. Under no circumstances can entries be accepted If not accompanied by the appropriate fee, unless special arrangements have been made with the Secretary. All stands MUST submit the appropriate Health and Safety documentation provided, and proof of public liability insurance.
2. Space will be allocated in units of 4m. frontage by 8m. depth. The Society reserve the right to make minor adjustments in order to maintain conformity on the Showground and to position exhibits as it sees fit.
3. Exhibitors will be allowed 2 Free Tickets for each of the first 4 Units and 1 for every two units thereafter, plus 1 Vehicle pass, limited to a maximum of 2. Tickets are not transferable. Additional tickets may be purchased at reduced prices. (THE SOCIETY does not operate a refunds policy for persons who arrive at the gate without admission tickets).
4. No Exhibitor may use for the description of his Exhibit more than 20 words in the Catalogue at the expense of the Society.
5. All persons who have entered and fail to exhibit shall forfeit all fees and charges.
6. All Exhibitors shall be in the Showyard and in the space allocated by 9.00a.m. on the Showday, after which time no vehicle will be permitted to enter the Showyard except for Sub-Contractors servicing. (See Regulation 17 below and Entry Form Additional Requirements).
7. No Exhibit, whether sold or unsold, may be removed from its site before 6.00p.m.
8. Electricity, Chairs and Tables can be provided by the Society on payment as set out in Entry Form - Additional items .
9. No turf shall be lifted by Exhibitors except where absolutely necessary for the display of any Exhibit. The cost of reinstating and making good must be defrayed by the Exhibitor.
10. No cheap Jacks or Hawkers allowed to rent space and in the interest of all Trade Stands, Exhibitors of miscellaneous articles for sale must state full particulars with the Entry Form.
11. The Sale of goods by shouting or any other annoying behaviour is forbidden. No exhibitor shall be permitted to take any collection or to sell raffle tickets, be it for charity or not, on the Showground, except on the Stand Space allocated to that Exhibitor. Persons infringing this rule are liable to have themselves and their goods removed from the Showground and the interpretation of this rule shall rest entirely with the Stewards and Officials.
12. Exhibitors must adhere strictly to the dimensions of the area allocated to them. In any case where an Exhibitor exceeds the space allocated, the Society through the Honorary Director, or his appointed Showyard Manager, will require the Exhibitor immediately to dismantle his exhibit and vacate the Showground, and his site fee will become forfeit.
13. The Society (through its Secretary, or Honorary Director or their duly appointed Agents) shall have full and free right to refuse to accept any entry, to cancel any entry after being made and accepted, to refuse admission to the Showyard of any proposed Exhibit and / or to remove or order to be removed at the risk and expense of the owner thereof any Exhibit which has been admitted to the Showyard. There shall be no obligation upon the Society to make or offer any explanation or reason for any such action and the Society shall not incur liability or responsibility in the matter.
14. The Society, its Officers or Servants shall not be responsible for any accident, damage, or loss, however caused, that may occur to any Exhibitor, or his servant, or to any article, animal or property brought into the Showground, or while entering or leaving the said Showground. Each Exhibitor shall be solely responsible for any loss, injury or damage that may be done to, or occasioned by, or arising from, any machinery or other article, or any animal or property exhibited by him, and it is a condition of entry that each Exhibitor shall indemnify and hold harmless the Society from and against all actions, suits, expenses, and claims on account of any such damage or injury. All exhibitors shall complete the health and safety documentation provided.
15. Exhibitors are requested to remove the whole of their Exhibits within three days after the close of the Show. Exhibits not so removed, may be moved at the expense and risk of the Exhibitor.
16. The Society will not be in any way responsible for any claim for compensation or otherwise in regard to the holding or withholding of the Show for anything arising out of or connected therewith.
17. At the discretion of the Gates Superintendent a Service Vehicle will be permitted to enter the Showground after 9.00a.m. on the payments of £10.00 deposit. This amount will be refunded if this vehicle leaves the Showground before 10.00a.m. by the same gate.
TRADE EXHIBITORS PASSES ARE NOT VALID AFTER 9.00a.m.
18. No objectionable articles to be sold.
