5. Road going vehicles and other mobile exhibits must have appropriate insurance cover for this type of event
6. Maximum speed on the showground is 5 mph
7. At no time whilst moving on the showground must there be anyone other than the driver on a tractor

I declare that during the whole period of the Show that my/our exhibit will be covered by insurance for Full Third Party Risks (including boiler explosion if applicable) with a minimum indemnity of £2,000,000 which is not prejudiced by use at the event connected therewith.
